**Henri Acelrad** is professor in the Institute for Urban and Regional Research at the Federal University of Rio de Janeiro (Brazil), and researcher at the Brazilian National Council for Scientific Development. He writes on environmental conflicts and planning. He is editor of *Revista Brasileira de Estudos Urbanos e Regionais*, and earned his Ph.D. in economics at the University of Paris I (Panthéon-Sorbonne), France.

**Elias Beriatos**, architect, city/regional planner and geographer, is professor at the Department of Planning and Regional Development, University of Thessaly (Greece). He is President of the Greek Planners Association, Vice President of the International Society of City and Regional Planners (ISOCARP) and Vice President of the European Council of Town Planners (ECTP). He has published numerous articles and made presentations at international conferences concerning spatial and environmental planning, urban management and decentralised interregional co-operation.

**Robert Cervero** is professor and chair of the Department of City and Regional Planning, University of California, Berkeley (USA). He is internationally known for his work on transportation and land use planning. He was the first-ever recipient of the Dale Prize for Excellence in Urban Planning Research. He serves on the editorial boards of *Urban Studies*, *Journal of Planning Literature*, and *Journal of Public Transportation*, chairs the National Advisory Committee of the Active Living Research Program of the Robert Wood Johnson Foundation, and is a Fellow with the Urban Land Institute and World Bank Institute.

**Aspa Gospodini** is associate professor of urban planning and design in the Department of Planning and Regional Development, University of Thessaly, Volos (Greece). She is an architect and an M.Sc. and Ph.D. graduate of Bartlett School, University College London (UK). Her research and publications concern urban morphology and design, urban landscape, urban redevelopment and regeneration, and place identity. She is on the editorial boards of *Journal of Urban Design*, and *International Journal of Sustainable Development and Planning*.

**Jaques Donzelot** is senior lecturer in political science at the University of Paris X Nanterre (France) and researcher consultant at the French Housing and Urban

Department. He is a member of the board of the review *Esprit*. His interest is in the comparison of the urban, social and security policies between France, European countries and North America, and his last book was about this subject: *Making Society Together: the policy of the city in USA and in France* (Ed. Seuil 2003).

**Robert Freestone** is associate professor of planning and urban development in the Faculty of the Built Environment at the University of New South Wales in Sydney, Australia. His main research interests are in the evolution of urban planning theory and practice, metropolitan restructuring, the built landscape, and planning education. He is currently President of the International Planning History Society.

**Thomas Hutton** is professor of urban studies and city planning in the Centre for Human Settlements, School of Community and Regional Planning, at the University of British Columbia in Vancouver (Canada). His research includes theoretical and normative implications of new industry formation within inner city districts, and the implications of industrial restructuring for urban transformation within the Asia Pacific. He holds a D.Phil. in Geography from Oxford University.

**Faustin Kalabamu** is senior lecturer in urban and regional planning at the University of Botswana. A Ph.D. graduate of the University of Kwazulu-Natal (South Africa), he has worked and taught in Tanzania, Bangladesh, Zimbabwe and Botswana. He has researched and published widely within the field of urban planning, especially on housing, gender and land issues in Botswana and Southern Africa.

**Luciana do Lago** is an architect and professor in the Institute for Urban and Regional Research at the Federal University of Rio de Janeiro (Brazil) and researcher at the Observatório das Metrôpoles network. Her research concerns urban policy, spatial mobility and social inequalities in the great cities. She published the book *Desigualdades e segregação na metrópole (Inequalities and segregation in the metropolis: Rio de Janeiro in a period of crisis)* (Federal University of Rio de Janeiro 2000).

**Nicholas Low** is associate professor at The University of Melbourne (Australia). He has taught planning theory, urban studies and environmental ethics in the Faculty of Architecture, Building and Planning, and has published many international journal articles and books. Low's interests include urban planning, politics and state theory, environmental justice, participation, transportation, decision-making and land markets.

**Alan March** is lecturer in urban planning at The University of Melbourne (Australia). He has worked as an urban planner in Western Australia, Victoria and England, and teaches planning practice, urban design and planning theory. March's research ranges from the theorisation of practical planning issues, developing

**Bruce Stiftel** is professor of urban and regional planning at Florida State University (USA). He writes on collaborative processes in environmental decision-making, as well as the development of urban planning educational institutions. Former president of the Association of Collegiate Schools of Planning, and founding chairperson of the Global Planning Education Association Network, he is reviews editor of *Planning Theory*, and a fellow of the American Institute of Certified Planners.

**Alison Todes** is a research director in the Urban, Rural and Economic Development Programme in the Human Sciences Research Council (South Africa). She is an honorary professor at the School of Architecture and Planning, University of the Witwatersrand (South Africa). She was previously professor of planning at the School of Architecture, Planning and Housing, University of Kwazulu-Natal. She has researched widely on urban and regional development and planning, and has a Ph.D. in planning from the University of Natal.
